FINAL RECORD OF DECISIONS

I. CHAIR'S ANNOUNCEMENTS

The Chair recalled the President's decisions of 22 April 2021 on measures in relation to COVID-19, which remain in force until 6 June unless renewed, amended or revoked before this date.

The necessity for the Members to be able to participate in election observation and other missions was raised in the expectation that the current travel restrictions would be lifted soon.

The Chair informed the Coordinators about the state of play of AFET reports as per the Annex.

The Coordinators agreed to set up a Working Group (WG) to scrutinise the thematic programme on Human Rights and Democracy and to closely work with AFET and DEVE Working Groups in order to provide input for strategic orientations and scrutinise the implementation of the human rights and democracy cross-cutting objective of the Global Europe/NDICI instrument. They also decided to discuss the concrete modalities of the DROI WG and their involvement with AFET and DEVE at the next Coordinators' meeting.

2. DROI own-initiative reports and recommendations 2021

Coordinators endorsed the proposal of the Greens/EFA Group to draw up an implementation report pursuant to Rule 54 of the Rules of Procedure and Annex III of the 2002 CoP decision on the EU Guidelines on Human Rights Defenders

3. First annual event on the Global State of Human Rights co-organised by the European Parliament and the Global Campus of Human Rights (GCHR)

Coordinators welcomed the initiative of co-organising an annual event with the GCHR. Suggestions made by the Coordinators will be included in the draft programme.

4. Inter-parliamentary meeting on corporate responsibility for serious human rights abuses in third countries.

Request for authorisation to organise the inter-parliamentary meeting in close cooperation with the JURI committee and during the second week of December (tbc)

5. DROI opinion to the INTA report on the review of the Generalised Scheme of Preferences (GSP) regulation

DROI Coordinators decided during their meeting of 1 December 2020 that DROI should appoint a rapporteur for an opinion on the review of the GSP regulation at a next meeting, with a view to following this issue from a human rights perspective and request an opinion to the INTA report once this is procedurally possible

4. SEDE Standing Rapporteur in SEDE for the scrutiny of relevant parts of EU/UK Trade and Cooperation Agreement

Coordinators decided to nominate the Chair to be SEDE's Standing rapporteur

for the scrutiny of the Agreement.
