Unfortunately, the Lebanese government has returned to the process of forcing the Syrian refugees to return to the Syrian regime through compromises, reconciliations and arrests on false pretexts and in direct - violation of UN and European resolutions

The actions and decisions taken by the Lebanese government came from Aoun's team led by Minister Gebran Bassil in Aoun's stream for upcoming electoral reasons and in a clear alliance with pro-Iranian Hezbollah policy and the foreign minister in total absence of the rest of the Lebanese government, including Prime Minister Saad Hariri - This policy is consistent with the policy of Russia and Iran to force the Syrian refugees in neighboring countries to return under the roof of the criminal regime. Because of the crimes of these militias, these refugees fled - and we hold them responsible for the safety and security of the Syrian refugees in Lebanon. And the abandonment of children and women in the open and that the crimes of enforced disappearance and arbitrary detention and genocide do not fall over time and that the prosecution before international courts will soon be the right of all those who participated in these crimes - group or individual from the Lebanese state T any job title
