FINAL RECORD OF DECISIONS

1. State of Implementation of the Commission Work Programme – AFET Input for the Conference of Committee Chairs

The Chair informed the Coordinators about the request for committees input to the Commission Work Programme and explained the procedure. A first draft by the Chair will be circulated to the Coordinators and the groups will be requested to contribute focussing on the key messages. Based on the groups' input, a final text for approval of the Coordinators will be circulated. The deadline for committees' contributions to the CCC is 18 May 2020 at the latest.

The committees' contributions should represent the official position of the committees and consist of maximum ten key messages. As per the usual practice, out of the ten messages of AFET, two are drafted by its sub-committees.

2. Implementation and EP scrutiny of the Global Europe Instrument

The Coordinators decided to:

- Endorse the tentative overall timeline (as per annex)
- Give a mandate to the Chair of the AFET Working Group for External Financing Instruments to draft a concrete proposal on the future scrutiny structures and modalities, in close cooperation along with the AFET Co-Rapporteurs for Global Europe and for IPA III, and with DROI and SEDE, as regards their respective competences

3. Exchange of views with Stefano Sannino, EEAS Secretary General on the reflection process launched by the EEAS Secretary General on key elements for the EEAS' next decade

Secretary General, Stefano Sannino briefed AFET Coordinators on the scope of the reflection process and intentions on key elements for the EEAS, as the service enters into its second decade of existence.
